- Newton Road There had been reports of cones on Newton Road.
- Edgworth Road A member of the public had reported that an overhanging tree was blocking the footpath that ran behind Waitrose to the lorry park.
- **Girling Street to Newmans Road** A member of the public had reported that the footpath between Girling Street and Newmans Road was blocked by vegetation overhanging from a private garden.
