9. TO DISCUSS THE HIGHWAYS LIST

Members discussed the following points;

• Melford Road Speeding – Members reviewed the data from the speed indication device (SID) that had been monitoring the traffic coming into Sudbury on the Melford Road between September and November. The raw data could not identify individual vehicles or types of vehicles, but it did show how many vehicles passed in each hour and their average and maximum speeds. The Town Clerk agreed to investigate how the software could be used to display the data in different ways to help the police target speeding motorists. The Town Clerk would also share the data with Suffolk Highways and the police. Members agreed to review the SID data of other locations monitored during 2026.

- Update on resurfacing Cllr Ms J Carter had forwarded an email from Suffolk Highways with the details of their plans for carriageway resurfacing schemes for this financial year and for FY2026/27 in Sudbury.
 - o Machine Surfacing:
 - C755 Newton Road, Sudbury from Newton Road junction (include roundabout) to Station Road (25/26).
 - A131 Ballingdon Street, Sudbury from Ballingdon Bridge to surface joint near Bulmer Road (26/27)
 - A131 Cross Street, Sudbury from Gregory Street to Ballingdon Bridge (26/27)
 - U8703 Priory Road, Sudbury from the A131 junction to Tudor Road (26/27).
 - Surface Dressing:
 - A134 Springlands Way, Sudbury from Tesco roundabout to Melford Road roundabout (26/27).
 - C743 Middleton Road, Sudbury from surface joint near the A131 junction to the county boundary (26/27).
- The junction of Croft Road and Gainsborough Road had flooded during the recent heavy rain.
 This appeared to be caused by blocked drains as had often happened at this point in previous wet weather. The Town Clerk would report this on the Suffolk Highways Reporting Tool.
- The bollard outside Toast on East Street had been knock over and was at a very low angle. The Town Clerk would report this on the Suffolk Highways Reporting Tool.
- There was a dangerous pothole on Ballingdon Hill about 50m beyond the 30mph signs. The Community Wardens would be asked to take photos so that the Town Clerk could report this on the Suffolk Highways Reporting Tool.
