Apologies for absence were received from Councillor Ms E Murphy.

No requests for dispensation had been received.

5. MINUTES

RESOLVED

That the minutes of the meeting of the Finance Committee held on 6th June 2023 be confirmed as an accurate record and signed by the Chairman.

6. ACTIONS FROM PREVIOUS MINUTES

- Recipients of Grant Aid had all been contacted. The only organisation that had not yet responded was The Bridge Project – they had been asked to advise when they were likely to hear the results of their applications for funding from other sources, as the Grant Aid was dependent upon other monies being raised.
- The Internal Audit report had been received and noted by the Full Council.
- The RFO had started preparatory work towards adding fixed assets to the accounts software. The aim was to bring a list of write-offs, and also possibly some additions, to the next Finance Committee meeting in September.



- The work on restructuring the reserves had been actioned.
- The Annual Governance and Accountability Return (AGAR) had been published.
- Some of the new bins had already been delivered.

7. TO APPOINT A MEMBER TO CONDUCT THE FIRST QUARTER OF INTERNAL CONTROL CHECKS

RESOLVED

That ClIr A Owen be appointed to conduct the first quarter 2023-2024 control checks, and that ClIrs P Berry-Kilby, N Younger and M Barrett would conduct the checks for the remaining three quarters of the financial year.

The Town Clerk advised that, due to the changeover of RFOs, the new NatWest savings account had not yet been opened as agreed ay the February 2023 meeting of the Finance Committee. As interest rates had increased in the meantime, he believed that better rates could be obtained by reviewing the deals currently on offer.
